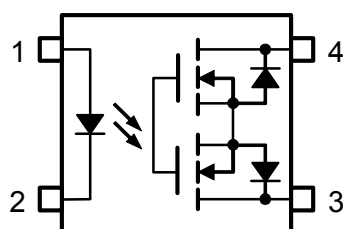
The TOSHIBA TLP3216 is an ultra-small photorelay suitable for surface-mount assembly. The TLP3216 consists of a GaAs infrared-emitting diode optically coupled to a photo-MOSFET and is housed in a 4-pin package. Its features include low Off-state current and low output pin capacitance, enabling it to be used for high-frequency measuring instrument applications.

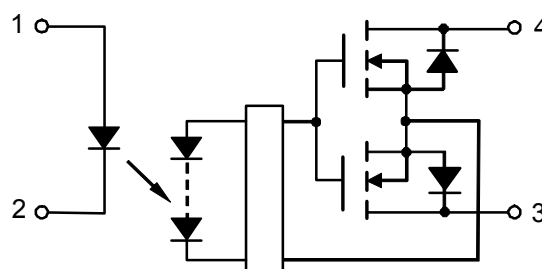

Pin Configuration (Top view)

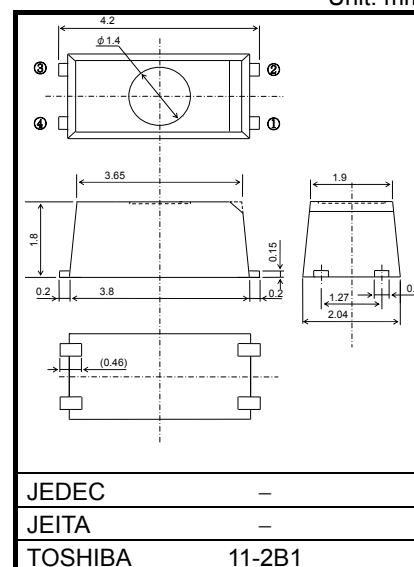


1 : ANODE

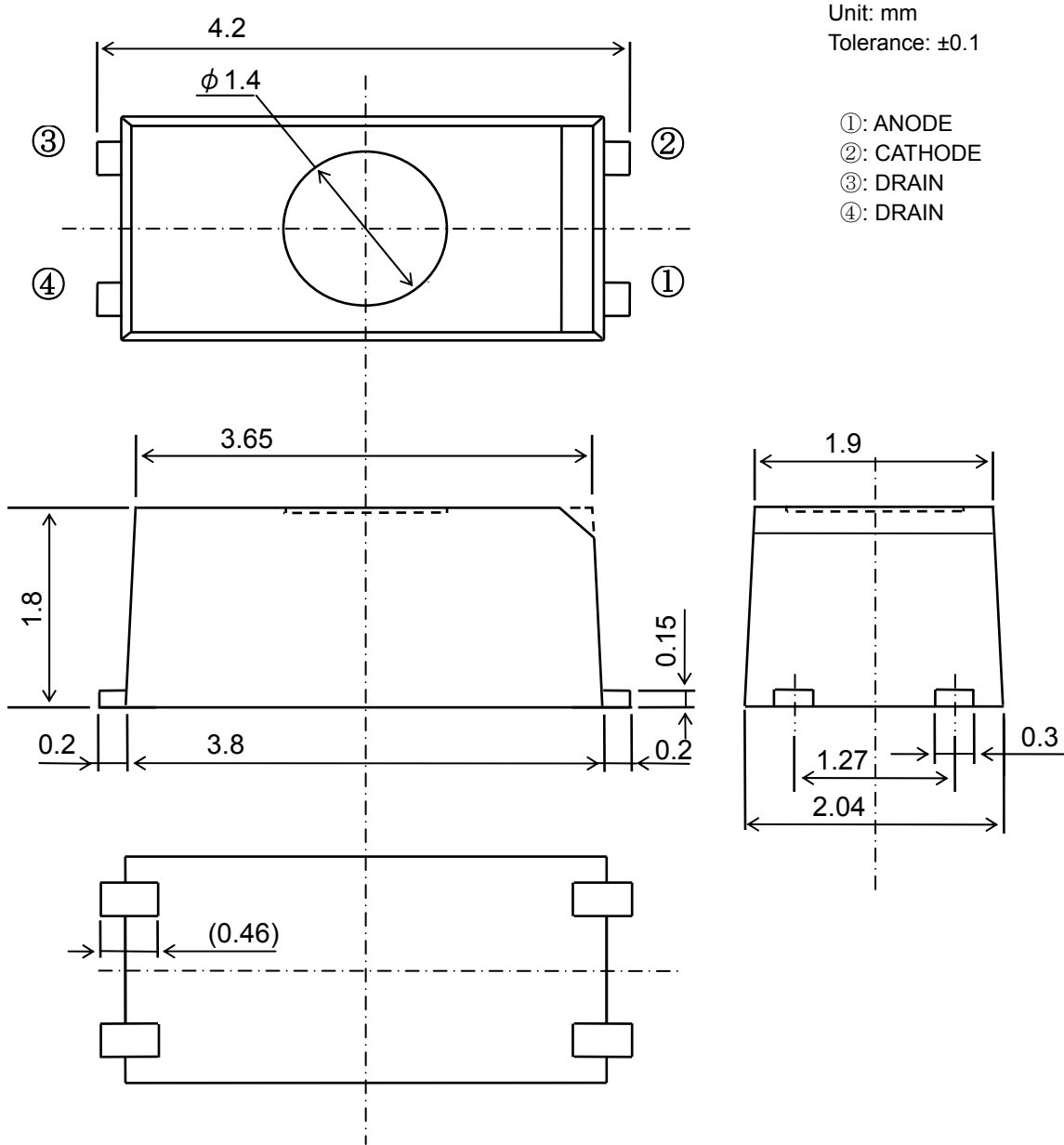
Note 4: Switching time test circuit
