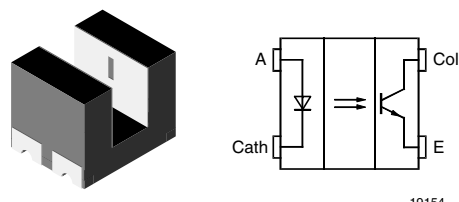


Subminiature Transmissive Optical Sensor with Phototransistor Output, RoHS Compliant, Released for Lead (Pb)-free Solder Process

Description

The TCPT1200 is a compact transmissive sensor that includes an infrared emitter and phototransistor detector, located face-to-face on the optical axes in a surface mount package.

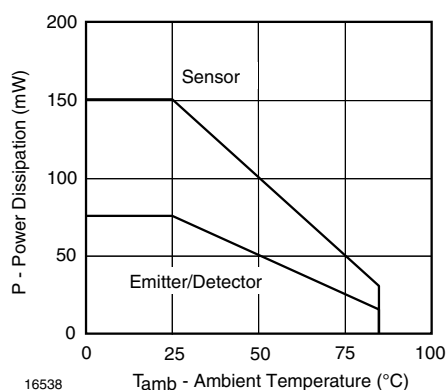


Figure 1. Power Dissipation Limit vs. Ambient Temperature

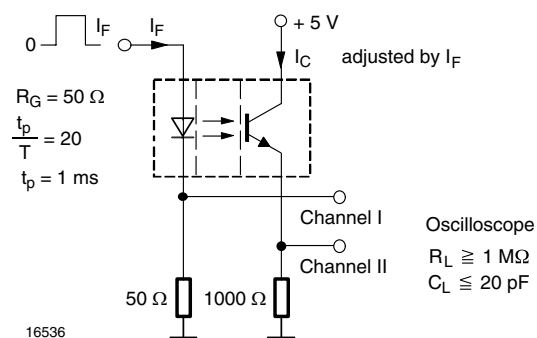


Figure 2. Test Circuit for t_r and t_f

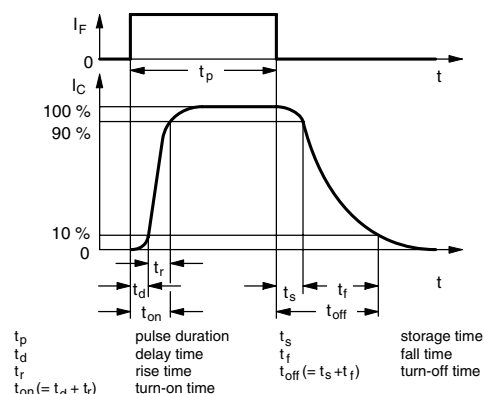


Figure 3. Switching Times

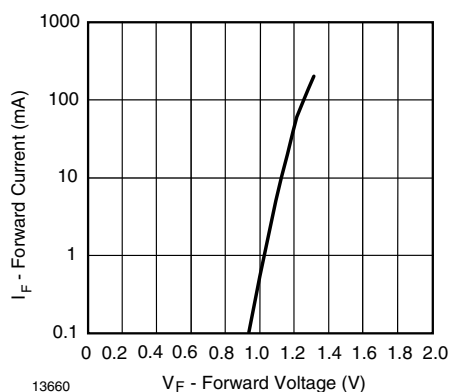


Figure 4. Forward Current vs. Forward Voltage

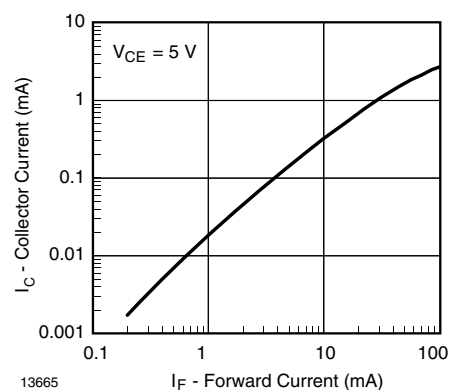


Figure 6. Collector Current vs. Forward Current

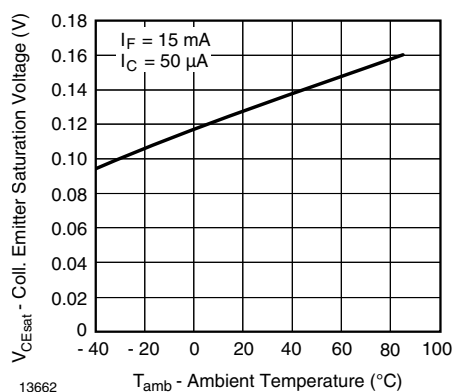


Figure 5. Collector Emitter Saturation Voltage vs. Ambient Temperature

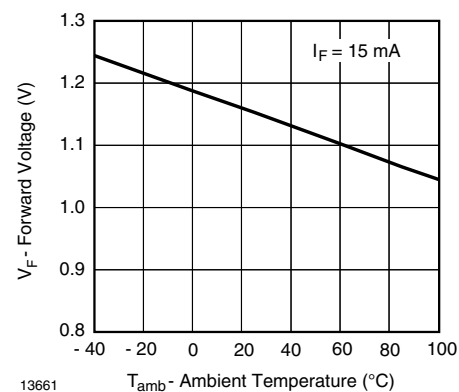


Figure 7. Forward Voltage vs. Ambient Temperature

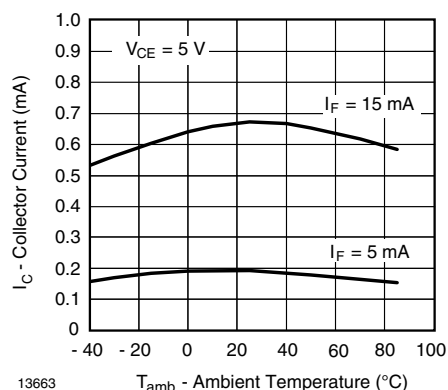


Figure 8. Collector Current vs. Ambient Temperature

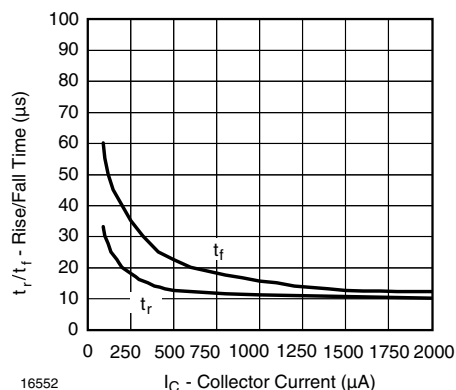


Figure 11. Rise/Fall Time vs. Collector Current

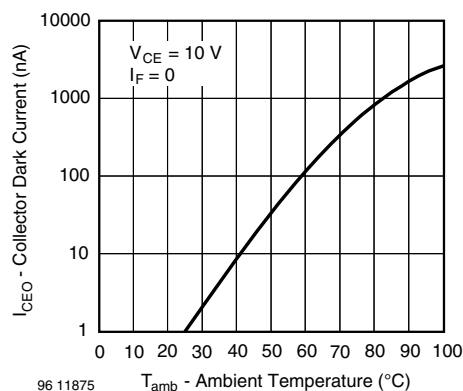


Figure 9. Collector Dark Current vs. Ambient Temperature

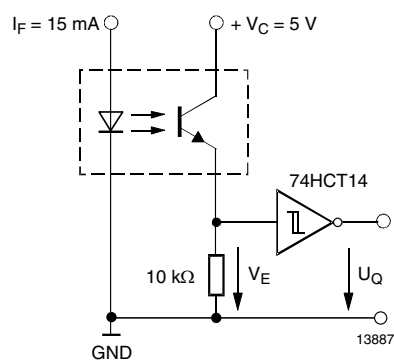


Figure 12. Application example

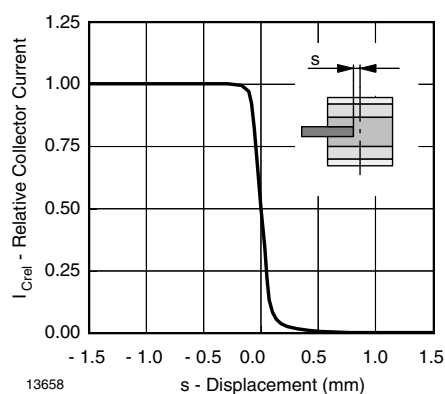


Figure 10. Relative Collector Current vs. Displacement

Reflow Solder Profiles

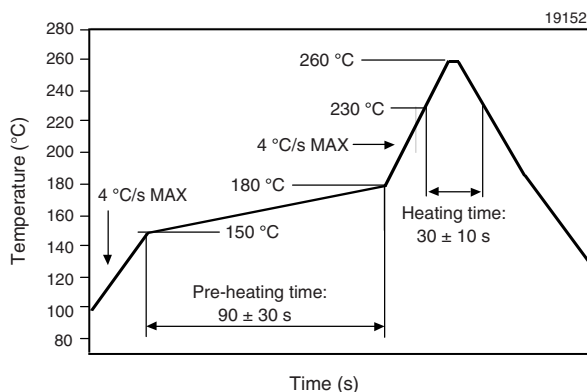


Figure 13. Lead (Pb)-free (Sn) Reflow Solder Profile

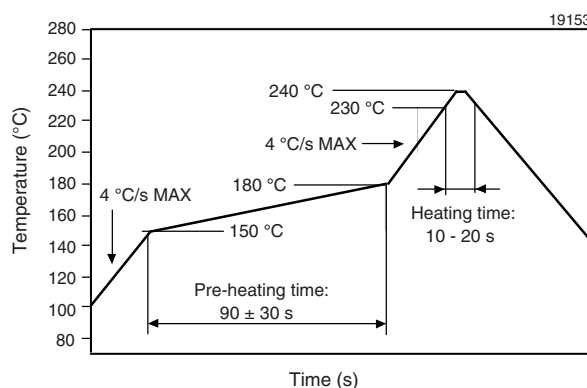


Figure 14. Lead Tin (SnPb) Reflow Solder Profile

Drypack

Devices are packed in moisture barrier bags (MBB) to prevent the products from absorbing moisture during transportation and storage. Each bag contains a desiccant.

Floor Life

Floor life (time between soldering and removing from MBB) must not exceed the time indicated in J-STD-020. According JEDEC, J-STD-020, this component is released to Moisture Sensitivity Level 2, for use of Lead Tin (SnPb) Reflow Solder Profile (Figure 14) or Level 3, for use of Lead (Pb)-free (Sn) Reflow Solder Profile (Figure 13).

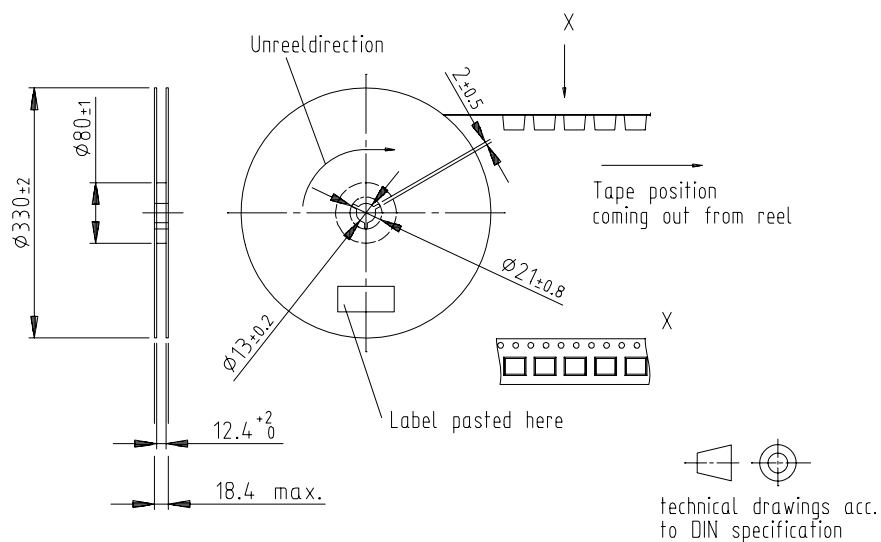
Floor Life: 12 month (Level 2) or 168 hours (Level 3)

Floor Conditions: $T_{amb} < 30^{\circ}\text{C}$, $\text{RH} < 60\%$

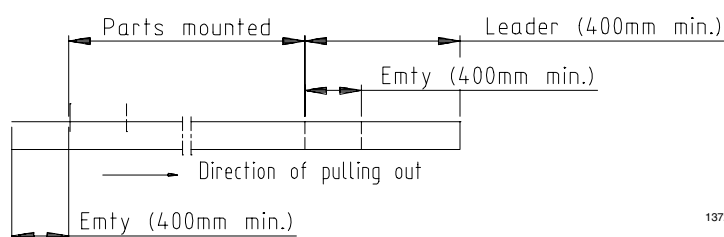
Drying

In case of moisture absorption, devices should be baked before soldering. Conditions see J-STD-020 or Label. Devices taped on reel dry using recommended conditions 192 h at 40°C ($\pm 5^{\circ}\text{C}$), $\text{RH} < 5\%$ or 96 h at 60°C ($\pm 5^{\circ}\text{C}$), $\text{RH} < 5\%$.

Dimensions of Reel and Tape in millimeters

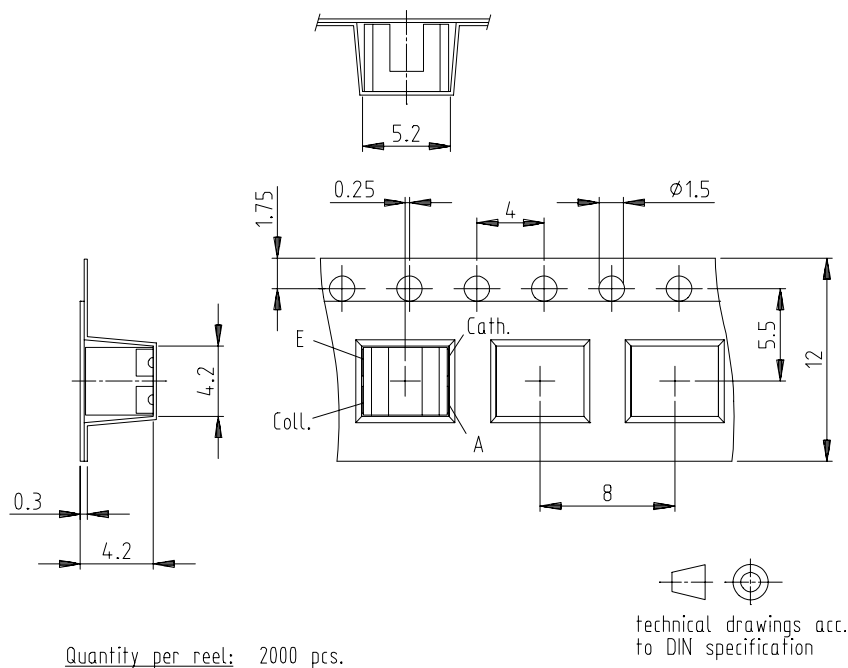


Leader and trailer tape:



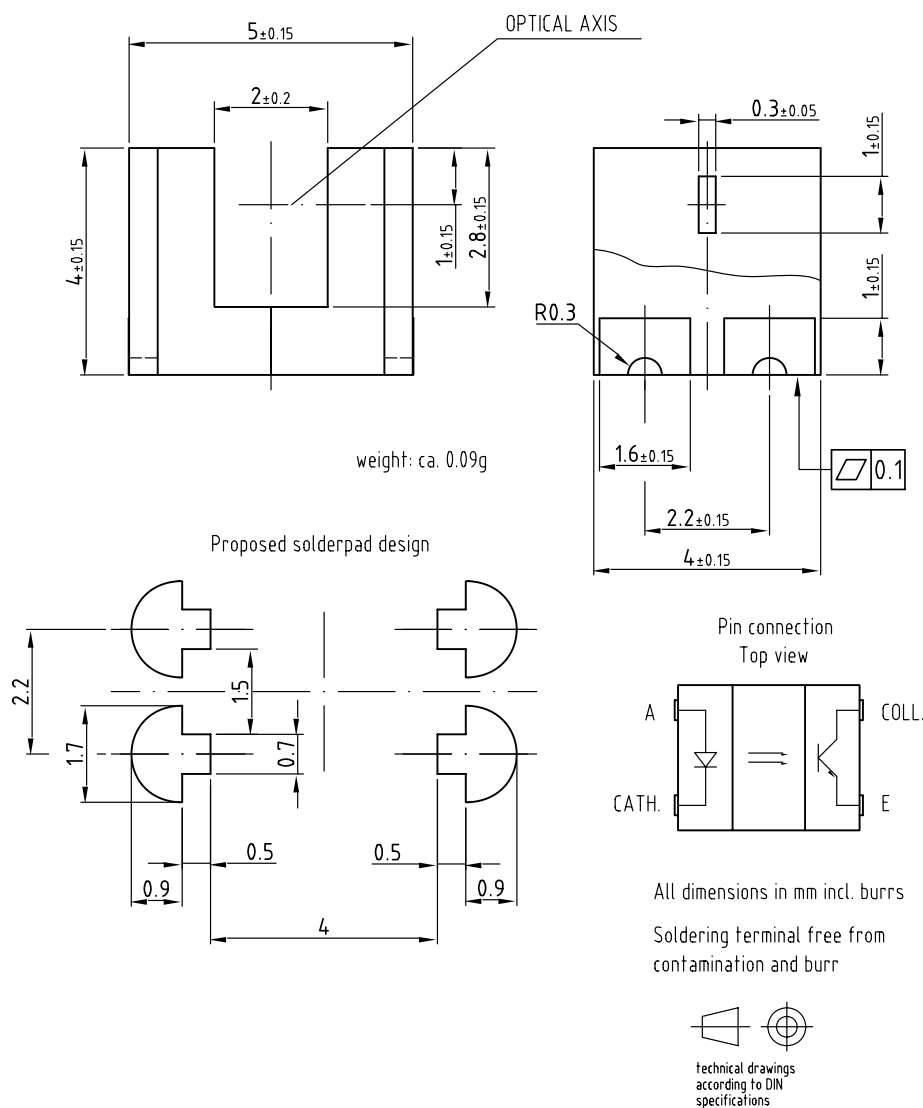
