## Notice on Usage

$V_{\text {th }}$ can be expressed as the voltage between gate and source when the low operating current value is $\mathrm{I}_{\mathrm{D}}=1 \mathrm{~mA}$ for this product. For normal switching operation, $\mathrm{V}_{\mathrm{GS}}$ (on) requires a higher voltage than $\mathrm{V}_{\text {th }}$ and $\mathrm{V}_{\mathrm{GS}}$ (off) requires a lower voltage than $\mathrm{V}_{\text {th }}$.
(The relationship can be established as follows: $\mathrm{V}_{\mathrm{GS}}$ (off) $<\mathrm{V}_{\mathrm{th}}<\mathrm{V}_{\mathrm{GS}}$ (on).)
Take this into consideration when using the device.
