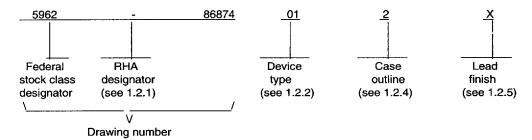

1. SCOPE

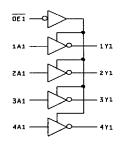
FIGURE 2. Truth table.

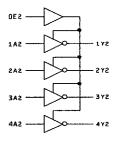


FIGURE 3. Logic diagram.

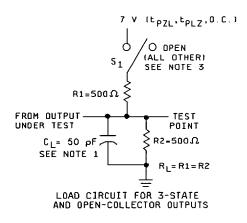
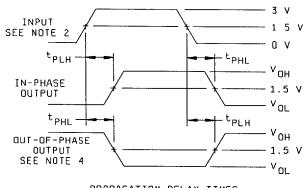


FIGURE 4. Test circuit and timing waveforms.

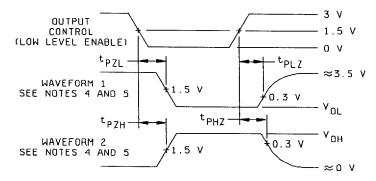
