












VOLTAGE WAVEFORMS





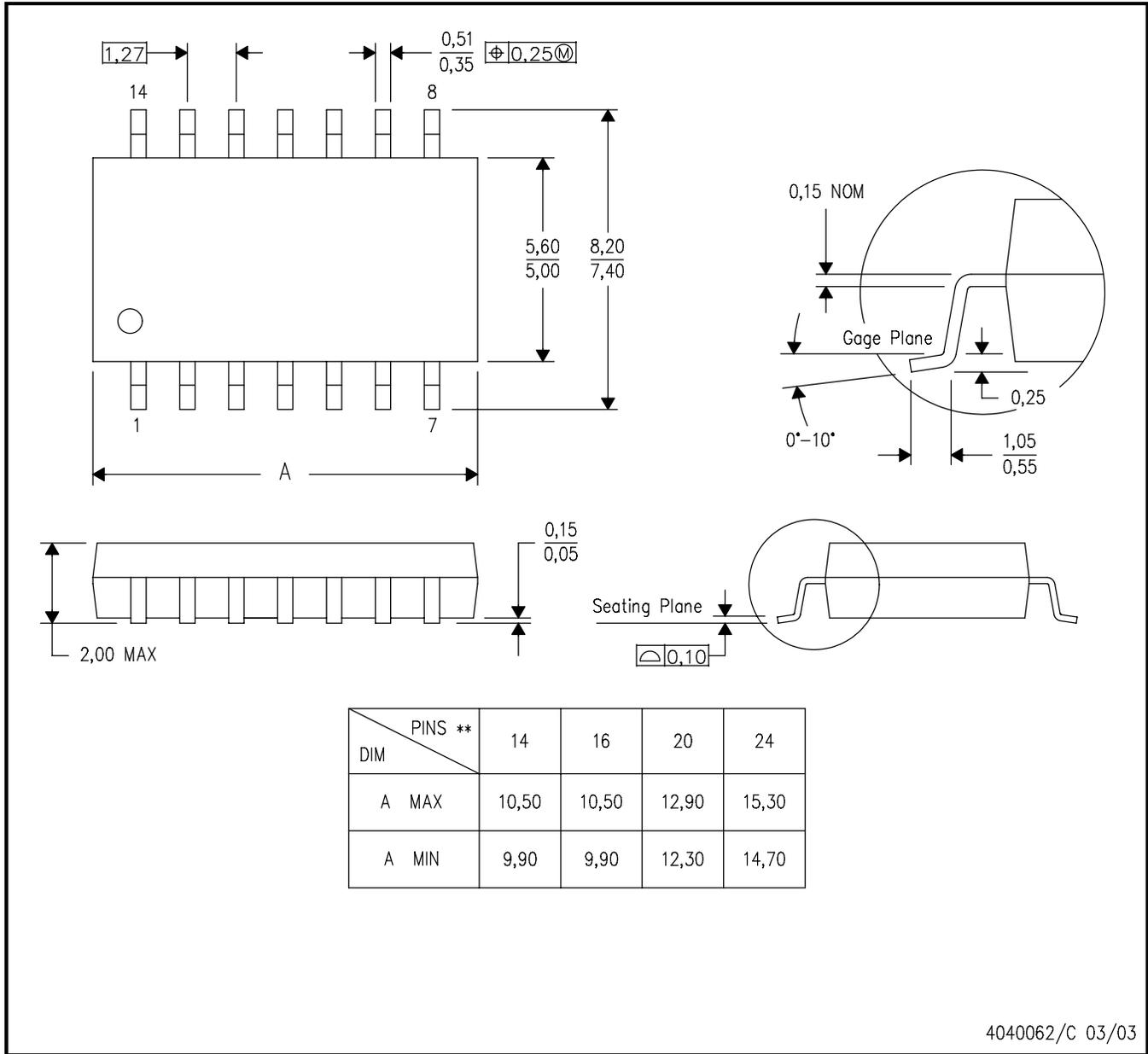
